**Scope of Work:**

Labour supply of 15 (Fifteen) manpower /day for regular removal of spillage cleaning in various locations of primary crushing plant. Material to be cleaned will includes boulder breaking, accumulation, cleaning, scraping, hosing etc. and loading of accumulated material into hand trolley, tractor trolley, dumper/ trucks, charging into chutes, bunkers, conveyors, tanks, pits etc.

**Period of Completion:**

305 (Three hundred five) days from date of supply of start of the work (Excluding holidays & Sundays)

**Working period & Responsibility:**

8.00 A.M. to 1.00 P.M. & 2.00 P.M. to 5.00 P.M. on all working days. The job to be carried out will be explained to the contractor or his supervisor every day & they will be responsible or carrying out the assigned quantity of work.

**Payment:**

11 (Eleven) R.A. bill and 01 (one) Final bill shall be paid.

**Insurance:**

You are to arrange Insurance coverage for manpower engaged for the work.

**Gate Pass:**

Bidders have to arrange gate pass on their own for 20 (Twenty) persons at least so that full quota of manpower (15 Nos.) could be supplied. One supervisor shall be arranged to look after the job.

**Award of contract:**

**Contract for labour supply will be awarded to successful bidder L1.**

**Penalty:**

Penalty will be imposed on pro-data basis for short supply of manpower than desired 15(Fifteen) manpower on day-to-day supply as below:

- i. Up to 12 manpower supplied → No penalty
- ii. Manpower supplied below 12 & up to 9 → Penalty of 20% of the offered cost per manpower.
- iii. Manpower supplied below 9 up to 5 → Penalty of 25% of the offered cost per manpower.
- iv. Manpower supplied below 5 → Full cost per person shall be deducted

**Rejection of Contract:**

**If concerned Engineer-in-Charge finds that jobs are not being done properly and there are slackness in work or progress is not satisfactory, then reminder shall be issued to the party for the improvement and even then not improved then contract shall be cancelled**

**If the contractor refuses to execute the work being L1, then party's EMD shall be forfeited.**

**Safety:**

You have to arrange all tools & tackles at your own cost like shovels, Gumboot, Gloves, Helmets, Goggles, etc. to all the persons engaged daily.

**Firm Price:**

Price quoted shall remain firm till the completion of the work.

**Rules and Regulations:**

You have to follow all security, safety and labour rules of the Corporation.

**Security Deposit:**

You have to submit an amount equivalent to 5% of the awarded value of the work as security deposit in form of Demand Draft in favour of UCIL payable at State Bank of India, Jaduguda.

**Medical:**

Medical fitness certificate for all employed persons from recognised doctor must be submitted to safety officer of UCIL before start of work.

**Start up work:**

Within 10 (ten) days of award of work order.
